

... and agreed priorities ...

Strategic Engagement Focus 2020 (Q1-2)

- Persuade Central Government of the relevance and credibility of LEPs. Mandate LEP Executive to lead this 'LEP Voice'.
- 2. Manage the post-Brexit transition on all relevant issues: Inc. skills, export, inward investment.
- Seek agreement on funding certainty post March 2021. Prioritise simplicity and security with emphasis on long-term investment – and credibility/understanding of SPF. Demonstrate to HMG that LEPs are 'ready to deliver at pace'.
- 4. LEPs delivery focus is 'clean and inclusive growth'.
- LEPs offering a complimentary approach to de-carbonisation and mobilisation from the private sector.



We really stepped up the activity

- 10 meetings with the PM, Chancellor, SoS and other Ministers.
- > 20 Economic Recovery Working Ministerial and Officials Group meetings.
- 15 Business roundtables involving well over 350 local company leaders.
- 3 SoS BEIS Taskforces, several Select Committee and APPG appearances.
- 20 LEP Network Board calls a fivefold increase in engagement and scrutiny.
- Multiple calls with CBI, FSB, BCC, BAC etc.
- Multiple policy interventions, recommendations and proposals.
- > 30 Media interviews/calls, webinars, papers, press releases (75) and opinion pieces.
- And who knows how many Zoom/Teams calls!

And this is just the Network!



But there is still much more to do

- We lack deep relationships with Treasury.
- Getting to some Ministers is still a challenge.
- Funding allocations for 2021 and beyond are not finalised
 - Capacity and Growth Hub funding: some certainty but what quantum?
 - Skills Capital, Levelling Up, NIS, UKSPF: vital we influence the detail.


